

Application Procedures

Requirements:

- Checking account that is open and in good standing – 2nd page of app taken into the bank and have the bank employee stamp or provide business card with signature.
- Pass a criminal background check
- Verifiable source of income- 2 most recent paystubs from each applicant
- Rent may not exceed **33%** of total income
(take rent amount and divide by gross income (before taxes) to get % amount)
- 65 and older \$25 application fee waived

Approved Application Procedures

- Upon Approval, Applicant can secure the rental unit with a security deposit (equal to rent amount) **after** application is approved to hold/ stop advertising on said unit.
- Rentals operate on a first-come, first served basis with an approved application.
Thus, if there are two approved applications for one unit, the first to come in with the deposit would be able to secure the rental.
- A rental unit cannot be held with a deposit for more than 2 weeks while empty and ready without rental payments and legal occupancy beginning.
- Your Security Deposit is a formal commitment to rent the dwelling.
- A **Utility Form** must be completed before new residents will be given possession of keys.

Lease Signing

- Will need a copy of each applicants driver's license's
- All adults in household must appear on and sign lease.
- First month's and Last month's rent due upon move-in** and must be **paid with a check off of the verified account** (no money orders, cash, etc.).
- Prorated rent** = Rent divided by number of days in the month. Take daily rate and multiply by number of days occupying.
- Pet fee (if applicable) of \$250 will be due and is non-refundable. Limit 2 pets.
- A **Condition of Unit Form** will be issued and is to be returned no later than two weeks after move-in date.
